Companies...

- Host a pink-themed fitness or Zumba class or a salon/spa day.
- GIT Your Pink On Day corporate sponsored events employees dress in pink, or jeans, or other fun apparel and donate \$ to GIT for the privilege.
- Raffle baskets.
- Ask your customers and clients to support GIT: donate for a particular service (e.g. a monetary donation for each car wash or reusable bag purchased through your business). Restaurants can donate a percentage of receipts for October or another time period.
