Through personal stories, accurate facts, and shocking statistics "Unfair!" encouraged young people to critically think about abortion rhetoric, biological facts of the child in the womb, and how abortion affects women. HLA created the Pro-life Healthcare Alliance to promote the pro-life healthcare philosophy and develop a network of pro-life healthcare providers, attorneys, and patient advocates. Printed materials include "Informed: a patient's guide to critical medical decision" and "Imposed Death: euthanasia and assisted suicide." HLA released a new "Informed" DVD as video magazine in the spring of 2016.
