It is the responsibility of the Exhibitor to pick up artwork the day following end of exhibit during gallery hours, or by arrangement. The Gallery committee will attempt to notify Exhibitor of the need to remove Exhibitor's artwork within 30 days. Any artwork not picked up after 30 days Crossroads Carnegie Art Center will contact the artist in accordance with ORS 359.205.
