FULLY VACCINATED (within 6 months)

FULLY VACCINATED AND BOOSTED

I HAVE BEEN EXPOSED BUT HAVE NO SYMPTOMS

Employees must test, but are required to work while results are pending.

I HAVE SYMPTOMS

Employees must quarantine and are not permitted to return to work until cleared.

DOMESTIC OR INTERNATIONAL TRAVEL

Employees are NOT required to quarantine upon return to Alaska.

May immediately return to work.

Must test for COVID-19 72 hours after arrival in Alaska and submit results.

FULLY VACCINATED (more than 6 months ago)

TESTED POSITIVE WITH COVID (within 3 months)

INTERNATIONAL TRAVEL

Employees must quarantine upon return to Alaska and not permitted to return to work until cleared.

Must test for COVID-19 72 hours after arrival in Alaska and submit results.

(CDC recommendation: Obtain a negative COVID-19 test one day prior to returning to the U.S.)



LOW LEVEL PROTECTION

NOT FULLY VACCINATED, NOT VACCINATED - and -

HAVE NOT TESTED POSITIVE WITH COVID (within 3 months)

I HAVE BEEN EXPOSED BUT HAVE NO SYMPTOMS

Employees must quarantine.

Employees or support recipients will be considered for clearance upon receipt of a negative test taken after 72 hours.
