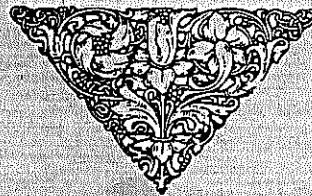

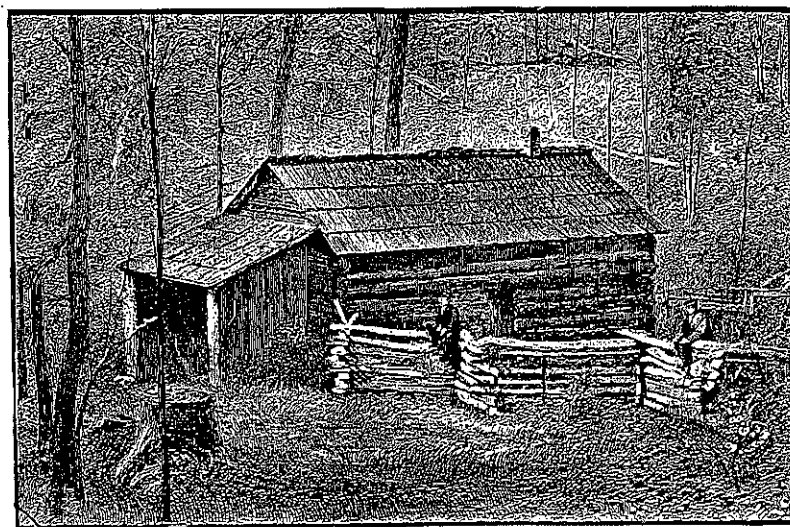

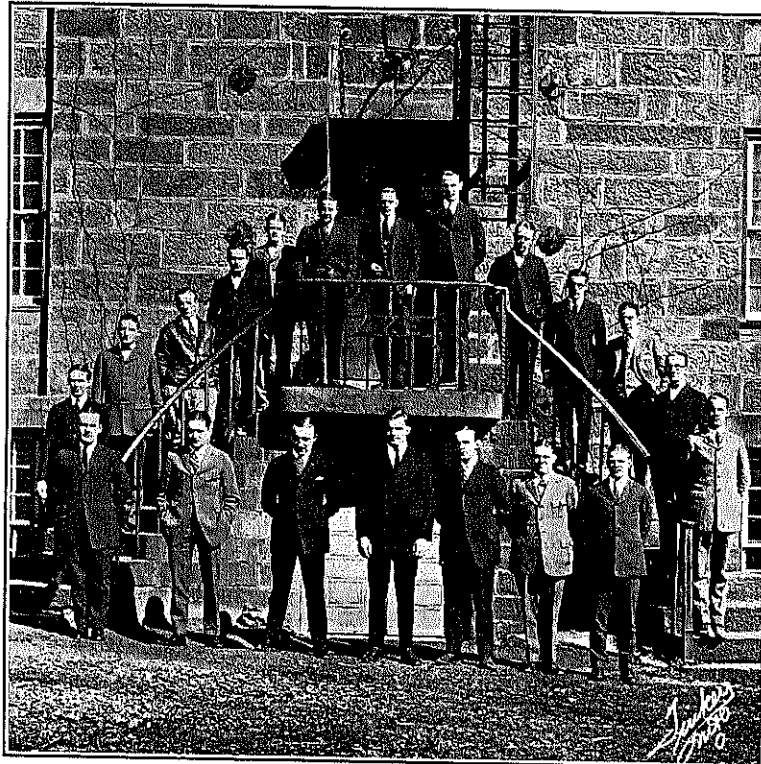

Football at Kenyon could hardly be called a success, nor yet could it be called a failure, but it most certainly was unusual. Out of seven games played the purple won one, lost one, and tied five.

Muskingum was the first to meet Kenyon, and after a series of unfortunate plays, tied the score, 7-7. The Hill had expected an easy victory and was somewhat disappointed, but still retained confidence in the team. Wooster came next week to Benson Field, our first Conference game, and bringing with them a record of being undefeated for six years.

There is no question but that this was the best game played by our men; the final score was 3-0, with Wooster on the short end. The rest of the season was one damned tie after another, with the exception of Case, which was a catastrophe.

Lambda had two men with the first string, and two others as substitutes. All four made a bid for back field jobs. Alling gave their time to help build up the team, and their work was not unappreciated. Both are expected to make regular berths on the team next year.

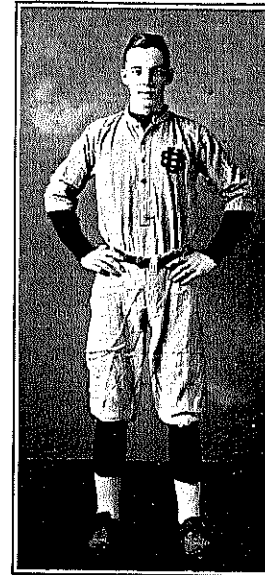

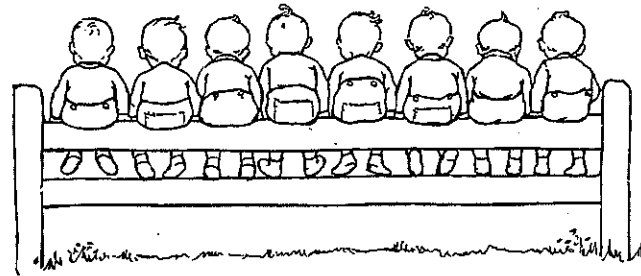

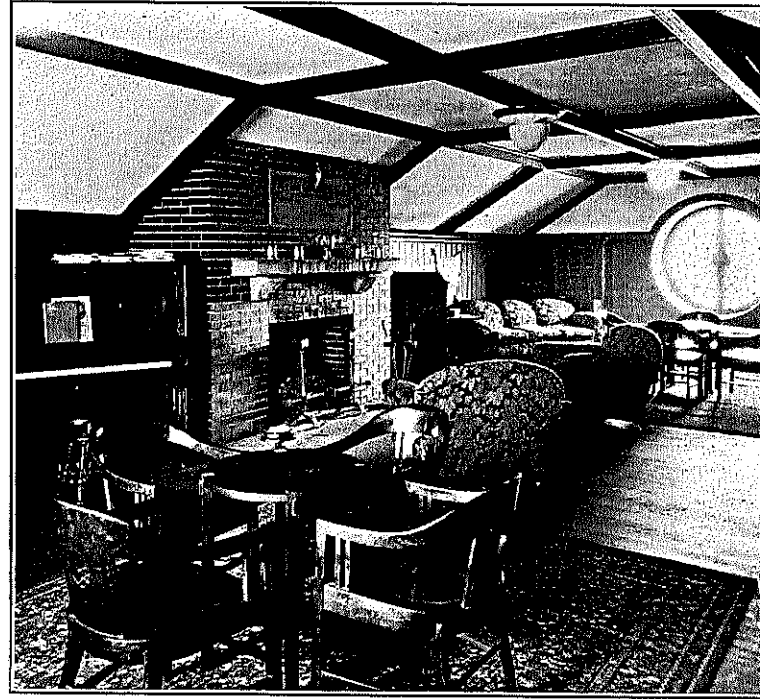
Scholastically Speaking

Before much is said on this subject we wish to apologize to the Alumni for the present state of affairs. However, we want to call your attention in the first place to the fact that the Wing this year has been badly overbalanced. We have only three upper-classmen, also, several men were forced to drop out of college during the first semester, giving us a quantity of Five's to overcome.

An honest effort has been made to keep the standing of the Wing on a higher plane, and, as proof of this we can say that only one of the pledges failed to make the hours necessary for his initiation in February. The report for this month's work has been much more favorable than those of preceding months, and we believe that this semester will show a marked improvement.



Refurnishing the Bulls-Eye



As many of our Alumni already know, the Active Chapter has been doing considerable during the past year, especially in making the Bulls-eye more attractive.

When the Bulls-eye was finished, in the years before Prohibition, the most suitable sort of a parlor was one that would stand up under hard usage. For that reason, strong, substantial chairs and tables were built and given to the Wing. All of this furniture has endured many years of hard wear. Even now, much of it is still in very good condition.

Times are changing, however, and what is needed in every Division is a lounging room that is arranged for comfort as well as for endurance. The tide here at Kenyon has been turning toward rooms where men can read, play cards, or study and be comfortable while doing so. The Chapter, this year, realized that the Bulls-eye

was in a far worse condition than any other place on the Hill. For that reason we made special efforts to improve the appearance of West Wing generally, but particularly the Bulls-eye. During the winter we bought two rugs, an upholstered davenport, and two upholstered chairs. Besides this, we have had floor plugs put in the four corners of the room to provide for lamps or any other electrical attachments. During Easter vacation the entire Wing was repapered.

Of course the cost of all these improvements has been met by the men living here. We have had for our object not merely a more cheerful place for us to live in, but have tried to do something to influence our Alumni to come back more frequently.

Our plans for re-furnishing the Wing throughout were explained in a Chapter Letter sent out last month. The replies we have had to that letter have been very few, although all those who took the trouble to reply at all expressed themselves as being heartily in favor of the plan.

You who have been out of college for several years have doubtless forgotten most of the unpleasant things that happened while you were here. We venture to say that you have forgotten that you ever were ashamed of the appearance of your room. We realize full well that it is our duty to provide our own furniture, and we do not believe we have ever suggested anything that is, in principle, any different from that. With the Chapter constantly changing it is practically impossible to secure a system of uniform furnishings. There are too many objections to that plan to make it feasible. Our plan is to have the Alumni advance the funds to refurnish all the rooms, and then have every man in the Wing pay a rental each semester on his term-bill to take care of future replacements.

We have been glad to pay off a few hundred dollars each year from the debt on the Bulls-eye. At the present rate the entire amount will be wiped out in four or five years. Considering all that we have done during the past two semesters we do not feel that we are at all unreasonable in asking our Alumni to subscribe a sufficient amount to carry out the plans we now have.

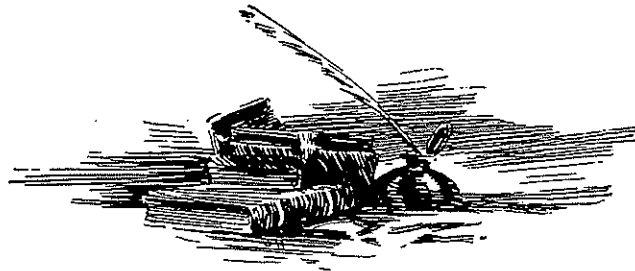
Evidently there are many whose views do not agree with ours. We, therefore, make this plea for your views on the subject, and for your objections, if any.

Pledges

All the Alumni of Kenyon know the pledging system on the Hill is far from perfect. However, Lambda managed to get her quota of good men. As a result of this pledging of men immediately upon their arrival, several were later dropped. It is only fair that the Chapter itself assume the blame for allowing men to be pledged who later were dropped, and for this reason we are making more adequate preparations for next fall. The opposite page is for the use of the Alumni—fill it out and address it to the Chapter, and you will aid us materially in our efforts to avoid a repetition of this year's unfortunate occurrence.

During Rushing Week in September we pledged eleven new men and re-pledged one, H. E. Handy. Two of the pledges dropped out of college during the semester. At initiation seven men were taken in, one being ineligible because of studies. We hope to initiate him this June. It would seem from the above that Lambda was not as fortunate as she might have been, nor was she, but the fact remains that the Wing is better off than many other Chapters on the Hill. The men initiated are fully qualified to be Dekes, and we are sure they will maintain that high standard.

At the beginning of the second semester West Wing added four men to her new delegation. They are: G. H. Meredith, N. S. Graham, John Shepard, and Milo F. Clapp. Pledge Graham had previously worn a Deke button at Wisconsin, and we were glad to keep him on the right path. Pledge Meredith entered from Ohio State, Shepard from Illinois, and Clapp from Dartmouth.

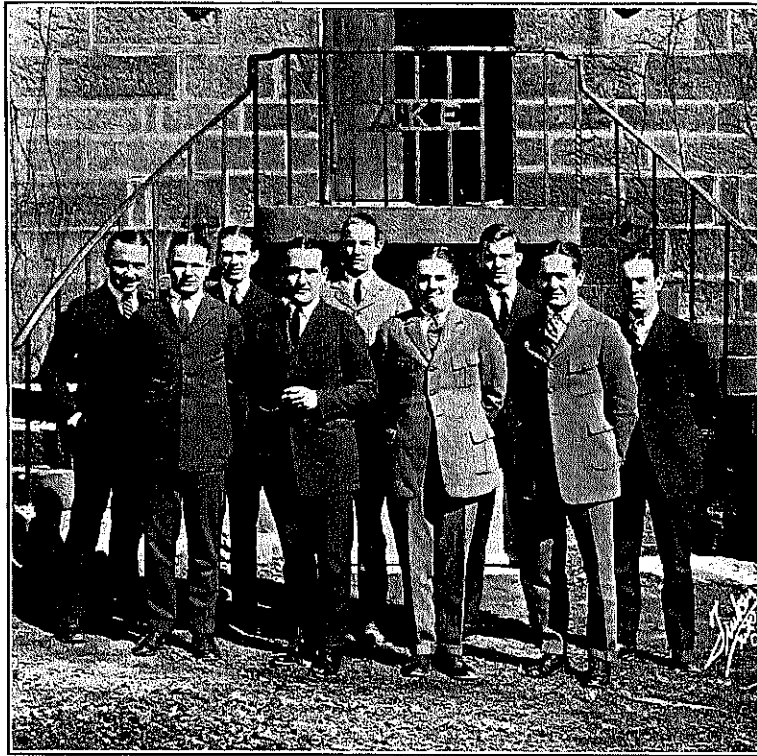

FRONT ROW: CLAPP, MEREDITH, FOX, J. SOMERVILLE

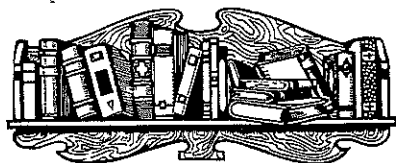
These men, after all, represent the future of the Chapter. It is only consistent that they receive mention, in spite of the fact that such action will no doubt gall their high and mighty rulers.

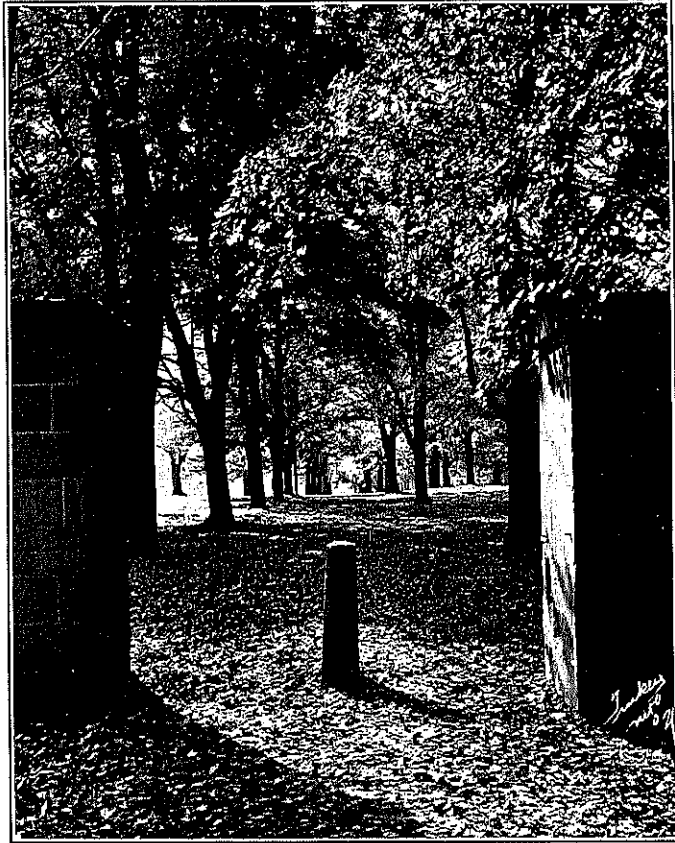
