By my acknowledgment/signature below, I certify that I am medically able to participate in this event, am in good health, am in proper physical condition and have sufficiently prepared or trained for my participation, and have not been advised to refrain from my participation by any health professional. I certify that there are no health-related reasons or problems which preclude my participation. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my further participation. I agree to abide by any decision of a race volunteer, staff member, or EMT relative to any aspect of my participation in this event, including the right of any staff member or EMT to deny or suspend my participation for any reason whatsoever. I attest that I have read all the event details and rules and agree to abide by them. I understand that bicycles, skateboards, roller skates or roller blades, and personal music players are not allowed in the race. I will abide by all race rules.

I fully understand that: (a) my participation involves risks and dangers of serious bodily injury, including permanent disability, paralysis, and death ("risks"); (b) the risks may be caused by my own actions or inaction, or the actions or inaction of others participating in the event, the condition in which the event activities take place, or the negligence of the Released Parties (defined below); (c) the risks may be caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, and lack of hydration; and (d) to participate in the activities, I must be covered by private medical insurance and I agree to recover all damages first from such insurance carrier for any and all injuries that occur in connection with my participation. I acknowledge that there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time, and I fully accept and assume all risks and other such risks and all responsibility for losses, costs, and damages that I incur as a result of my participation.
