


With a daily checkin-call from Iamfine you'll be reassured that your friends and family will be alerted if something happens to you.

- Has your pet ever fought with another animal? If yes, please provide details.

- How does your cat behave during veterinary visits?
- Please list current medications and any allergies.
- Is your pet current on his/her vaccinations? If not, please explain.

Thank you so much for coordinating the care and adoption of my pets at the time of my death. I hope the following information helps to find the perfect new home/family for them to live with for the remainder of their lives.

If any of my pets are quite elderly and their quality of life is not that great at the time of my death, I would prefer that they be euthanized. If that is the case, their ashes should be given to my Executor.

My private veterinary contacts & records are on file with Animal Humane New Mexico.

All do well at the vet.

DOGS - Abby, Teddy Bear and Bella

All three dogs are used to traveling in a car and do not need to be in a kennel. They will sit on your lap or in the back seat--very well behaved. They all use a doggy door and are completely house broken. None are fincky eaters. All will sit with you or by you when you are reading or watching TV. None have been around children much, but may do fine if the children are older and not rambunctious. All three dogs walk well on leashes—they prefer pull-out leashes so they can do their own thing—I walk all three at same time at least once a day for a mile to 2 miles. The dogs can be adopted independent of each other. All three dogs go to groomer at same time (Dawn at Doggie Den) and are well behaved, even though it is not their favorite thing to do. All the dogs sleep on my bed at night. I cook chicken soup with brown rice and vegetables or ground beef and barley & veggies for the dogs and rotate with "Blue" dog food. I mix "Blue" crumbles with all meals.

ABBY:

Abby is a 15 year old malti-poo who is in excellent health at this time. She was adopted from AH when she was two years old and has been with me ever since. She was Jack's little girl and she loved to sit in his lap. She still takes a mile walk each day and loves to sniff in all the bushes. She does well off leash, but with her loss of hearing you have to watch her so she just doesn't wander off—she gets in her own little world. She can hear you call her name if you use a very high pitch, loud voice. She doesn't really play with toys any more, but will chase



and romp with Teddy Bear if he pursues her. She's a great dog, loves to give kisses and follows me everywhere in the house. Very social, will introduce herself to most folks visiting our home and has no problem sitting on laps and giving kisses. Can shake hands—more like a high five! Abby does not have teeth, but it doesn't interfere with eating. She also had surgery on a rear leg (see medical records) but has no issues now that it is repaired.

TEDDY BEAR:

Teddy is a rat terrier/schnauzer cross. He was born at Animal Humane and I fostered him and two of his six siblings. Needless to say, I couldn't give him up and he is now 5 years old. He is in excellent health and is just the best! He loves to run and if taken to a park and is off leash he will run like crazy. I'd say he is a sprinter—goes fast for short distances. He thinks he is "big stuff" but is really my little "wuss". Walks a mile or more every day and likes to meet and greet every dog we meet—even the big scary ones! He isn't very interested in toys and could care less about balls. He just wants to be with you. He likes to get the



newspaper every morning with me (off leash). Very social – likes to greet everyone who comes to the door. Likes to be a "guard" when folks play basketball—bounces and barks and chases as ball is dribbled and then loses interest once ball is thrown! Loves to chase birds and bunnies and chippies—thinks it's a great game. Teddy knows a few tricks like hand shakes, down and roll over—he has been to beginning agility class. Be careful, Teddy Bear will attempt to get on dinner table if chairs are not pushed in. Have lost a few breakfasts and dinners because I forgot to push in chair! If you howl like a dog, Teddy Bear will join right in and sing his heart out!

Pet Trusts

- Provide the most control.
- Legally enforceable.
- Describe in detail what kind of care is required.
- Usually set up by an estate professional.
- Require a separate administrator/trustee from the pet owner.
- Require regular inspections of your pet(s) by the trustee.
- Designate a reminder beneficiary



How to State in Your Will

- I leave my Heeler mix Buster and \$x,xxx to John Smith, with the hope the money will be used for Buster's care. If John Smith does not survive me, I leave Buster and \$x,xxx to Jenny Brown, with the hope the money will be used for Buster's care.
- I leave my Heeler mix Buster to Animal Humane New Mexico and the sum of \$x,xxx for the general purposes of said non-profit.
- I leave any pets I may have at the time of my passing to _____.

Last Will and Testament of Stephanie Miller

I, Stephanie Miller, of Albuquerque, NM, declare this to be my Will, and I revoke all Wills and Codicils previously made by me.

Article I: Declarations

A. Marital Status - As of the date of this Will, I am unmarried

B. Children - As of the date of this Will, I have no living children.

Article II: Executor Provisions

- A. Executor I nominate my friend Jane Smith to serve as Executor of my estate and to carry out the instructions in this Will. If Jane Smith is unable or unwilling to serve or continue to serve, I nominate my friend John Smigh to be the Executor of my estate and to carry out the instructions in this Will.
- B. Bond No bond or other security shall be required of my Executor in any jurisdiction.
- C. Executor Powers I grant to my Executor the following powers:
 - 1. The power to exercise all powers of an absolute owner of property;
 - The power to retain, sell at public or private sale, exchange, grant options on, invest and reinvest, and otherwise deal with real or personal property;
 - 3. The power to borrow money and pledge any property to secure loans;
 - 4. The power to divide and distribute property in cash or in kind;
 - 5. The power to compromise and release claims with or without consideration;
 - The power to pay my legally enforceable debts, funeral expenses, expenses of last illness, and all expenses in connection with the administration of my estate and the trusts created by my Will;
 - 7. The power to employ attorneys, accountants and other persons for services or advice;
 - 8. Except as otherwise provided herein, the power to make, in my Executor's discretion, any distribution required or permitted to be made to any beneficiary under this Will in any of the following ways when such beneficiary is a minor: (i) to the guardian or conservator of such beneficiary's person or property; (ii) by utilizing the same, directly and without the interposition of any guardian or conservator, for the health, support, maintenance or education of such beneficiary; (iii) to a person or financial institution serving as custodian for such beneficiary under a Uniform Gifts

FREEWILL

You're almost done! Follow these instructions to make your will legally valid.

Read	 Read your will carefully, and make sure you understand everything. If there's anything you feel like you don't understand, please speak with a lawyer
Sign	 Find three witnesses and a notary. Your witnesses must be at least 18, mentally competent, and someone other than the notary. Neither witness, nor their spouses, should receive any gifts in your will.
	 You and your witnesses must sign and date your will in the same session.
	 While in the presence of your witnesses and notary, verbally acknowledge that this is your Last Will and Testament. For example, you could say: "This is my Last Will and Testament that I am signing and it represents my wishes for the distribution of my property at the time of my death." Then:
	 Sign your name on each page of the will using the signature lines provided. On the last page, also fill in the date where indicated.
	 Then have your witnesses sign and date where indicated.
	• Finally, ask the notary to complete the notarial acknowledgement.
Keep Safe	 Keep your original, signed will in a safe and accessible place, such as a fireproof box in your home.
	 Be careful not to remove any staples from your will, or allow pages to be ripped, a this may raise concerns in the probate court that your will had been altered.
	 Notify your executor nominees of the location of your will, and make sure they have access.
	 You can make and distribute copies of your signed will for reference to loved ones However, if your original, signed will cannot be found upon your death, the probate court may raise questions as to whether you intentionally destroyed you original will, and may not accept a copy of your will as proof of your wishes.
Update	 It is a good idea to update your will when you marry, have children, divorce, move or go through other major life changes.

Notify your nominees

Many attorneys recommend that testators notify the people they've nominated for important roles. This helps the nominees prepare and gives testators the chance to discuss their hopes and expectations.

Below are common reasons why some people prefer to see an attorney:

- Your estate is especially large or above the estate and gift tax exemption threshold (federal, state, or local). In 2020, the U.S. federal estate tax exemption is \$11.58 million per individual, for example.
- · You expect your wishes may be contested.
- You don't have access to witnesses.
- · You own property outside of your home state.
- You run or own a business.
- · You are physically incapable of signing the will.
- You are participating in medical treatments that increase the chances of your capacity being challenged.
- · You have a child, spouse, beneficiary with a disability, or you have a disability.
- You are participating in medical treatments that increase the chances of your capacity being challenged.
- You want to set up a trust for minor children so that their inheritance is released to them gradually, even after they turn 18.
- You have children from multiple marriages.
- · You have a premarital agreement that substantially changes your assets' position.
- You are in the process of a divorce.
- · You have, or want to create, a living or testamentary trust.
- · Your caregiver, doctor, or attorney is a beneficiary in your will.
