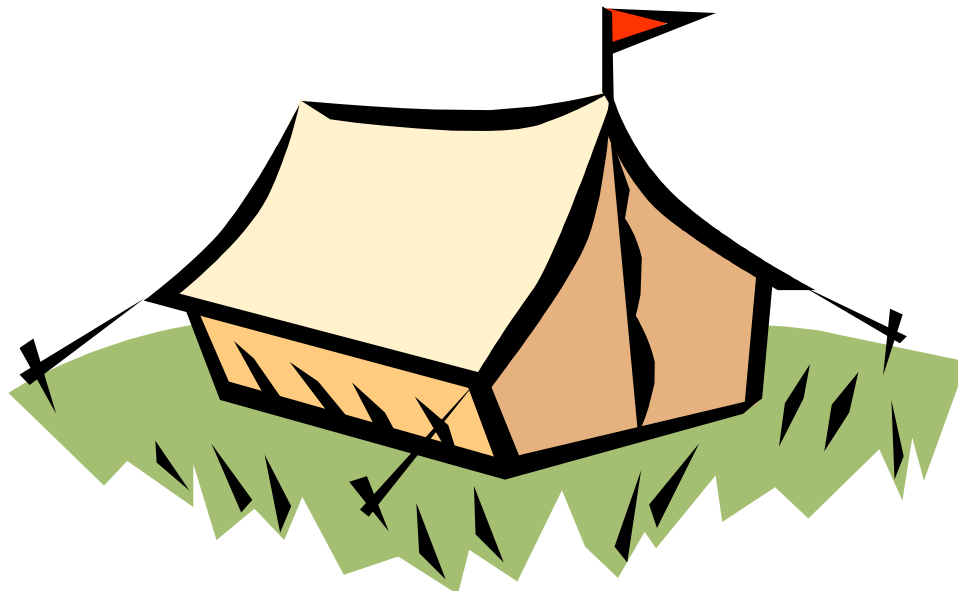

# CAMP SPRIG OVERVIEW

California Waterfowl's Camp Sprig introduces participants to waterfowl hunting and other types of outdoor activities. Campers learn from experts in a safe, positive and supportive environment.

At Camp Sprig, participants will learn about or hone their skills with shotguns, waterfowl identification, gear, decoys and lots more. Campers will receive Hunter Education instruction and complete the test for earning their Hunter Education certificate.

## ABOUT CWA

California Waterfowl (CWA) is a **501c3** non-profit organization whose mission is to grow California's waterfowl populations, wetlands and hunter-conservationist communities. Our vision is a California with thriving waterfowl populations, vibrant wetland ecosystems and respected hunting communities.

## Pre-Camp Instructions

# CAMP SPRIG PROGRAM INFORMATION

## Arrival and Departure

Campers are to check in at Grizzly Ranch on Friday at 5:00 PM.  
Please do not arrive early.

### Friday, July 12<sup>th</sup>

5:00 PM: Turn in paperwork, check in and store all personal belongings.

5:10 PM: Parents and campers will be given an overview of the camp. After the overview, campers will begin hunter safety instruction and parents are free to leave.

### Sunday, July 14<sup>th</sup>

3:00 PM: 'Graduation ceremony'

Parents should plan to attend a brief graduation ceremony on Sunday. Please arrive by 2:45 pm and relax while we celebrate your camper's experiences at camp. After the ceremony, the campers will be released to their parents or guardians and should plan to collect all their belongings.

**Note:** If the parent or guardian will not be picking up their camper, please inform the camp coordinator who they should be released to at the end of camp.

## Cancellation Policy

Circumstances arise that may result in you having to cancel your camper's registration. If we are able to refill the spot, your camp fee is refundable minus a \$20 processing fee. If we are unable to refill the spot, the entire camp fee is non-refundable.

## Contact

Campers will be very active during their stay at camp, and we don't anticipate them needing to contact anyone. They will be having a great time at camp learning and discovering new things. See emergency contact numbers if you must contact your child during camp.

## Food Regulations

Please do not supply your child with food, chewing gum, candy, etc. during their stay at camp. We provide ample, balanced meals, and numerous light snacks. The food can attract ants and mice to the campsite and may also cause hard feelings among the other campers. All food brought by the campers will be confiscated by the camp staff. Please let us know if your camper has a food allergy or restricted diet.

## Hospital

## Hunter Education

Hunter Education Instructors have the discretion of deciding whether a student is given the final examination after completing at least ten hours of instruction. Upon evaluation, if the student does not display the appropriate maturity level when handling firearms, the student will not be given the final examination. Students displaying inappropriate behavior will not be certified regardless of knowledge or skill level.

## Medical – First Aid

The Coordinator holds current First Aid and CPR cards. See *Camper Health Record* for additional information in case of emergency.

## Medications

All medications must have the child's name, medication name and strength, dosage and the prescribing doctor's name and phone number on each bottle. Also send written administering directions from the doctor. Please place medications and instructions in a zip lock bag with the child's name printed in bold letters on the outside. **Give bag and instructions to the camp coordinator for administration.**

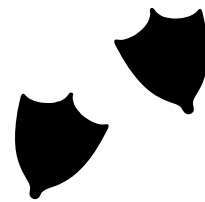
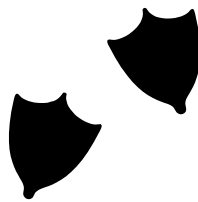
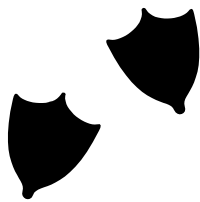
## Telephone Regulations

# DIRECTIONS TO GRIZZLY RANCH

(next to Grizzly Island Wildlife Area)

[4179 Van Sickle Road, Suisun City, Ca 94585](#)

- Hwy 80 to Fairfield
- Take Hwy 12 East toward Suisun City.  
Note: When you get off Hwy 80 you will travel a short distance before going under a bridge. Hwy 12 is the first left after going under the bridge.
- After 3.6 miles, Right onto Grizzly Island Rd
- After 5.4 miles, stay Right over Montezuma Slough Bridge
- After 3.3 miles, Right onto Van Sickle Road,  
Note: You should see “Welcome to Grizzly Island Wildlife Area”, look for white fence. If you get to the Grizzly Island Wildlife Area you have gone too far.
- After 0.4 miles, Right into Grizzly Ranch
- After 0.7 miles, Arrive at Grizzly Island Ranch. Check-in at CWA sign
