
Q1 What region of the state do you live in (check one)?



Q2 What regions of the state do you hunt waterfowl in (check all that apply)?



Q3 Where did you hunt waterfowl during the 2022-23 season?



Q4 How many days did you hunt waterfowl in 2022-23?




Q5 Did you hunt more or less in 2022-23 than the previous season?


Q6 Was your 2022-23 waterfowl harvest higher or lower than the previous season?

Q7 How many times did you hunt with licensed guides in California in 2022-23?



Q8 How many times did you hunt waterfowl out of state in 2022-23?








Q17 Where do you go to get information on hunting products? (Select all that apply)






















