The bag limit for pintails has increased to 3 for the 2025-2026 season—the first increase since 2018! This achievement is the

result of years of dedicated work by our advocacy team, who have been tirelessly pushing for better opportunities for hunters.

Northern Pintail Regulatory Strategy for 2025

The U.S. Fish and Wildlife Service has announced that the pintail bag limit will increase from 1 to 3 birds per day for the 2025-26 waterfowl season, following a new interim harvest strategy. This change is the result of years of advocacy by CWA and the work of the USFWS and Flyway Councils. The impact of this new limit will be assessed over several seasons to determine if it should become a long-term strategy or be modified. Recent research suggests that habitat changes, not hunting, have primarily affected pintail populations, and additional harvest opportunities may be sustainable. *Please head to our website for full article*.


Our Waterfowl Programs team has just wrapped up nesting season, including the Egg Salvage and Nesting Bird Habitat Incentive Programs.

This year, the Egg Salvage Program saw above-average participation from farmers and an increase in acreage enrolled. Unfortunately, the number of nests and eggs salvaged was below average, though still a significant improvement from last season. This was expected, given that the Sacramento Valley population of breeding mallards was reported at a record low, according to the breeding pair surveys conducted in the spring.

This was the second year that CWA and CDFW implemented the Nesting Bird Habitat Incentive Program, which includes the Delayed Cereal Grain Program, the Fallow Ag Program, and the Rice Levee Program. Funds from state duck and upland stamps are used to incentivize farmers to leave nesting cover in place until July 15th, helping to bolster local mallard and pheasant populations. This year, we saw an increase in both participating farmers and enrolled acreage. CWA staff also monitored a subset of these fields for nesting activity, finding a total of 52 mallard nests.



Wetlands Work

Construction efforts on Butte Valley Wildlife Area are complete for 2024. A brand-new managed brood unit (Unit 9A) was completed and ready for flood up later this winter. Seasonal wetland Unit 11-C3 was also completely enhanced as result of CWA and CDFW efforts. Wetland Unit 3 was nearly completed with finishing touches to be completed in 2025. CDFW managers are in the process of flooding up past completed projects with the newly installed water delivery pipeline system. Stay tuned for future updates regarding planned 2025 construction efforts at BVWA.
